HOST REQUIREMENTS:

- ❖ IBKC "Event Host Application" must be received and approved before your show date is advertised or scheduled. Application must be in office no later than (30) days of scheduled event date.
- The hosting Club/Kennel will stay in communication with *IBKC* Shows & Events Department to ensure a well promoted and smooth running show. Our Shows & Events Department can also assist in helping Club/Kennel select their Judge and Representative that best fits the needs of the show. Our *IBKC* Shows & Events Department is available at all times to answer any questions.
- The hosting Club/Kennel must contact the Superintendent and go over details of hiring the judge's and representative's work at your event. (You have received your Judge/Representative Contracts with your event approval letter.)
- ❖ Judge's and Representative's accommodations (travel, transportation, lodging, meals [dinner night before show; and during event]) must be secured and filed with the IBKC Shows & Events Department no less than (14) days prior to event date. Their pay must be in office within (30) days prior to event date.
- ❖ The hosting Club/Kennel must provide the Judge and Representative with adequate tools and supplies for them to complete their duties. This includes but not limited to show armband numbers; pens; forms; water; etc. Please confirm with your selected Judge and Representative on their required supplies.
- The hosting Club/Kennel is required to hold event insurance. The IBKC must be provided with a copy of insurance certificate within (14) days before the show date.
- Host will provide adequate staffing for the IBKC Representative to conduct a smooth flowing show (Minimum of 2 Helpers and Ring Steward; If you are having a Sporting Event a Ring Steward for that event is required as well). IBKC Representative responsible for ensuring rules and integrity of IBKC is upheld. (Failure to provide Staffing will incur following fees: No Registration Table Help: \$50.00; No Ring Steward: \$50.00 per show *Due to IBKC Representative at the completion of event.)
- All fliers; banners; posters must be submitted to Shows & Events Department for prior approval before posting; tweeting; and/or facebooking. Artwork must be approved and you must receive Press Release to post Artwork before releasing to public. Any posters, banners or fliers posted prior to approval will be deleted, fine of \$100.00 will be assessed and may lead up to termination of sanction event.

RULES & REGULATIONS:

- All Dogs participating in Sanction; Sporting; and/or Fun Show portion of show is required to be registered IBKC.

 Registration to registry will be available day of show via IBKC Representative at a discounted show price.
- ❖ IBKC Representative is and will not be responsible to administering and organizing your "Fun Show" Categories. They can assist in ensuring approved categories are being offered and direct participants to right area.
- Show entry fees may not be more than \$20.00 per dog per show (\$10.00 per dog per show for 3-6 mos. Entries) Show host may not charge more than the stated amount. Pre-Registration, and Single Registration @ Event Fees can be discounted with prior approval from IBKC Directors. (This will take place in lieu of "Temporary Registration")
- ❖ In the event of Cancelation due to emergency from the host within 30 days of the show, IBKC will refund Hosting Fees in full or allow to book for a later date. If cancelation is less than 30 days, IBKC will refund 50 % of Hosting fees or allow to book for a later date without any penalty.
- If any of IBKC representative or judge has to cancel for emergency reasons, IBKC will replace the representative or judge for the event at no additional transportation charges stated on previous Judge/Representative Contract.

- ❖ IBKC Certified Judge Fee \$200.00* (first 5 varieties and New Generation Handler Class); \$25.00 any additional breed or event, but not to exceed \$300.00. If you choose to use a Director of Judges to judge your event their starting fee is \$300.00* (Judge Fee must be paid to IBKC at least (30) days prior to start of show.) *Plus travel accommodations
- ❖ IBKC Certified Sport Event Judge Fee \$200.00 *Plus travel accommodations. (Judge Fee must be paid to Judge prior to start of show.)
- For Sporting Event; there may be Equipment Rental Fee and Transportation Fee for the Equipment based on location of show.
- ❖ Penalty for Host requirements not being met is \$50.00.
